**ENTRY AGREEMENT INCLUDING RELEASE AND HOLD HARMLESS**

**Sorensen Equestrian Park LLC Waiver** – Every person or entity executing this entry form agrees and represents that: 1. The person or entity executing this entry form and the horse (s) to be exhibited by the entrant are subject to and bound by rules of USEF and Sorensen Equestrian Park LLC and the rules of the entity or entities that are responsible for organizing and conducting the event (the “Shows”). 2. That permission to enter a horse and the rental of storage, stall, or tack space, if granted, shall not create a bailment between Reid and Linda Sorensen, Sorensen Equestrian Park LLC, the Show, the facilities leased by the Show, and the state wherein held, and the entrant or others and, at all times, horses and any other property belonging to or accompanying the entrant shall be under the care, custody, control, and supervision of the entrant. 3. The entrant agrees to fully indemnify and hold harmless Reid and Linda Sorensen, Sorensen Equestrian Park LLC, the Show, the facilities leased by the Show and the state wherein held, and their agents, employees, contractors, officials, officers, directors, successors and assigns from and against any and all claims, demands, penalties, actions, losses, costs, damages, injuries, liabilities and obligations, including but not limited to, any and all attorneys’ fees of whatsoever kind and nature which may be incurred by or asserted against any of them as a result of any act, failure to act, or neglect by the entrant, his agents, employees, riders, handlers, trainers, coaches, drivers, contractors or invitees or by any animal owned by, accompanying or exhibited by the entrant. 4. The parties executing this entry form, for themselves, their heirs, executors, administrators, successors and assigns release and forever discharge Reid and Linda Sorensen, Sorensen Equestrian Park LLC, the Show, the facilities leased by the show and the state wherein held, and their agents, employees, contractors, officials, officers, directors, successors and assigns from any and all rights and claims for any damage, loss or injury to themselves, other persons, horses or other property belonging to them to the fullest extent permitted by law arising out of or relating in any way to the Show and participation in the Show including, but not limited to, damages resulting from or due in whole or in part to any acts, failure to act, negligence, or neglect of other entrants, other entrants’ animals, Reid and Linda Sorensen, Sorensen Equestrian Park LLC, the Show, the facilities leased by the Show and the state wherein held, or their agents, employees, contractors, officials, officers, directors, or invitees, as well as for theft, vandalism, fire or casualty damage or damage arising out of any defects in the premises.

**Federation Entry Agreement**

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulteur or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. (the “Federation”) and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the competition may use or assign photographs, videos, audios, cable-casts, or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation Rules are governed by the laws of the State of New York and any action instituted against the Federation must be filed in New York State. See 908.4

**Federation Release, Assumption of Risk, Waiver and Indemnification**

This document waives important legal rights. Please read it carefully before signing.

**I AGREE** in consideration for my participation in this Competition, governed by Sorensen Equestrian Park LLC, to the following:  
**I AGREE** that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulteur, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death (“Harm”).  
**I AGREE** to release the Federation and the Competition from all claims for money damages or otherwise from any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Federation or the Competition.  
**I AGREE** to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Federation or the Competition.  
**I AGREE** to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.

I have read the Federation Rules about protective equipment, including GR 318 and EV113, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child’s participation and AGREE to all of the obligations of this Release on the child’s behalf.  
**I AGREE** that “the Federation” and “Competition” as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.

I represent that I have the requisite training, coaching and abilities to safely compete in this competition.  
I AGREE that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Federation on the official USEF accident/injury report form. BOD 1/16/05. Effective 12/1/05.
